I hereby give 30 days' notice as per the DCS cancellation policy I read and agreed to on signing up, found at the web address <a href="http://www.dynamiccorestudios.co.uk/cancellation-policy-procedures/">http://www.dynamiccorestudios.co.uk/cancellation-policy-procedures/</a>:

- Anyone is free to cancel their membership by giving a minimum of 30 days written notice prior to the payment date
  they wish to cancel from. Upon signing the membership agreement the signatory is agreeing to a minimum membership
  of 6 months.
- As above, this 6 month membership can be terminated at any time by giving 30 days written notice prior to the payment date that is to be cancelled from. Failure to follow this procedure will result in the member being held liable for the full 6 (six) monthly membership payments. At any point, even beyond the 6 month period, failure to follow this procedure will result in the member being held liable for a minimum of two months' payment. This includes, but is not limited to, failure to provide a request for a cancellation in writing and for Dynamic Core Solutions Ltd (on behalf of Dynamic Core Studios) to cancel any Direct Debits in accordance with the 30 days notice period. If the member cancels the Direct Debit via their bank prior to the final payment date based on the above terms, Dynamic Core Studios Ltd reserve the right to enforce payment in full of the full 6 monthly membership payments (with a minimum of two months payment, even beyond the member's first 6 months) plus any charges incurred for a failed Direct Debit collection. A request for the full amount outstanding will then be issued in writing with payment due by the 1st of the following month. Any late payment will incur an interest charge of 1% per day late. Dynamic Core Solutions Ltd may pass any outstanding debts to third party collections agents or small claims court at any time, and the member will be responsible for any additional charges this incurs.

I understand that my last and final direct debit will be taken from my account for the full month following this notice.

Any later and the deposit will not be returned (though the fob remains the property of DCS and should be returned regardless).
